B. History/Mission of Organization

History:

The Student Government Association at UConn Stamford has existed since 1963. The original group of student leaders formed the association, drafted and established a constitution, and elected officers to serve as the liaisons between students and the school's administration. Since 1963, the association has grown from a 9-member organization to a thriving association of student leaders from all studies and backgrounds that plans, organizes, and executes programming and events for the student body to better each student's experience at our campus. SGA plans to continually build a strong sense of community. Students involved not only facilitate the student body making connections through these events but also develop leadership, management, and organizational skills in assisting with Student Government operations.

The SGA provides programming and events using the Student Activity Fee each semester to fund a wide range of activities. In addition, 30% of the Student Activity Fee pool is reserved for registered student organizations (RSO's) who may use these funds when planning events and activities that are open to the student body.

Mission Statement: The SGA exists for the following purposes:

- a. To represent the interests of the student body to the administration of the campus.
- b. To represent the interests of the student body to the community.
- c. To supervise all student activities that are funded by the Association.
- d. To promote cooperation and support between all University of Connecticut campuses.
- e. To hold events and organize activities that will benefit the Association.
- f. To act in a way that represents the Association as a whole.
- g. To develop and fund extracurricular programming for the campus.
- h. To provide events and space for the community to grow connected and strong.

Student Fees

Fee-paying students pay \$40.00 each semester, for a total of \$80.00 per academic year.

Budget Narrative Questions

Please answer the following questions in support of your budget proposal:

1. How are you **spending your funds** now? Briefly describe the programs and services provided.

Currently our funds are used primarily to fund programming for the student body. 30% of total funds is allocated to current Tier II Registered Student Organizations (RSO's) to fund their programming and events. To get funds approved for their events, RSO's must submit a funding request to our finance committee. Once the finance committee has reviewed the funding proposal it is then brought to the General Senate Meeting, where the funding proposal is discussed and approved by the general senate of the organization. The remaining funds, 70%, is used for Student Government programming/events and operational costs.

SGA Programming and events:

This fiscal year we had approximately \$120,000 in student fees. \$84,000 of the total student fees will be used to fund Student Government Association (SGA) events. SGA plans and runs events for the all undergraduate fee paying students, both on campus and off campus. Some off-campus events are ticketed events, such as our Broadway trip and six flags trip. For these events Student Government Association covers a part of the ticket cost. Typically, we like to keep the cost covered by Student Government to \$40.00, which is the current student activity fee per semester. For on campus events, each semester, we typically have two to three novelty day events, holiday events (such as Halloween, thanksgiving dinner, valentine's day, earth day, etc.), one to three karaoke events, one to two entertainment shows (comedian, hypnotists, game show, etc.), Student appreciation/Destress day, and finals breakfast. With a significant increase in students at UConn Stamford, we expect to plan more events each semester to use all funds and provide students with more chances to attend more student government events.

In addition to our regular semester events, each semester we have a welcome week to welcome all new students and returning students. This fiscal year for Fall 2018 Welcome Week we budgeted \$15,000, estimating \$3,000 per event, and spent \$14,163 in total for the week. Welcome week included: stuff a husky, a luau party, go karting night, and a karaoke night. For welcome back week for spring 2019 we have budgeted \$8,000 for four events, approximately \$2,000 per event. We have budgeted less for spring welcome back week since the events tend to be smaller than fall welcome week events.

Part of the current funds for SGA is allocated to providing fifty copies of the New York Times to students four days a week during academic semesters. Funds are also allocated to general office supplies for SGA.

RSO Programming and Events

30% of our current funds are allocated to Registered Student Organizations. Funds for RSO's are allocated on a first come first serve basis; provided that the event is an appropriate expense and that the event is open to the student body at large.

We currently have 36 registered organizations. Tier I organizations are not eligible to receive funding from SGA. Tier II organizations may be eligible to receive funds from SGA.

2. Please explain any **significant changes in your budget/spending plan** for FY19 (July 1, 2018-June 30, 2019) and for FY20 (July 1, 2019-June 30, 2020) fiscal years.

For the 2018 - 2019 year, we noticed a dramatic increase in student population due to the implementation of the Stamford Campus Residence Halls. Last year, there were 34 RSOs on campus. We currently have over 36 RSOs on campus. With the increase in RSOs, there has been an increase in the request of funds from these RSOs. We currently see 4 new Tier II RSOs, which are eligible for funding. Currently, some of the Tier I Organizations are fulfilling their training requirements to become Tier II organizations.

3. Do you anticipate any **changes in income from other sources** (non-student fee) during the FY19, FY20 and FY21 fiscal years? If so, briefly explain.

We do not expect any significant changes in income from other sources because we have similar programs with similar funding.

4. What are the current and projected **levels of your reserves/fund balances**? If you have a fund balance, please describe the use/purpose of these resources.

Our current fund balance for this fall semester is \$59,939. The Fund balance has increased primarily due to RSO's not utilizing all of the funds available to them. We continue to budget at this level (30% of student fees collected), as it is required by our Constitution. We have started planning additional programming funded by SGA to utilize some of the funds that have not been spent in the past. Should the RSO's begin using all of the funds available to them, we will spend into the reserve some (estimated \$5,386 this year). However, with the significant reserve we have, we believe this is acceptable.

5. Please describe the organizational priorities in your proposed FY21 budget. Are there any concerns/issues the Committee should be aware of when reviewing your budget?

In our FY21 budget our organizational priority is to continue to meet the need of the student body as the student body population keeps increasing significantly each year. To accomplish this goal SGA's FY21 budget provides larger budgets for our regular semesterly events.

There are no concerns/issues the Committee should be aware of when reviewing our FY21 budget.

6. **Are you proposing an increase in your organization fee for FY21?** If yes, please provide the rationale for your request (include any information regarding the limits of your organization if the fee increase is not approved). What steps has your organization taken to reduce expenses and/or increase other revenues? What is the dollar increase you are asking per year? On the budget spreadsheet, please complete an additional column for FY21 that outlines how your organization will allocate the additional revenue from the proposed fee increase.

No, Student Government Association will not be proposing an increase in our organization fee for FY21.

7. **Relative to your fund balance (if you have one), what do you anticipate your accounts payable (items to pay for) and accounts receivable (money to collect) will be over the last two months of the fiscal year (May and June)?**

During May/June we do not expect to see an increase in accounts receivable other than our monthly student fee transfer. Accounts payable will be primarily to pay for programs and events that occurred late in the spring semester (New York Times Subscription bill, etc.). Two expenses that will occur at the end of the semester are the Six Flags trip and the yearly SGA officer/directors transition retreat.

8. Please describe how students (number and/or percentage of total student population) **utilize your services and/or participate** in your programs? Do faculty/staff (number/ percentage) benefit? Do members of the local community (number/percentage) benefit?

Appendix A provides a more detailed breakdown of FY18 SGA and RSO events. Appendix A shows 90% of funds were used for fee paying students and 10% were used for non-fee paying. "Non-fee paying" can be considered: faculty/staff, graduate students, part time students, and occasionally members of the community.

With the addition of a residence hall in fall of 2017 we have been actively working to keep up with the demand of students. We plan to see a continuing gradual increase in the student body over the upcoming years of both residential and commuter students. To keep the student body engaged, our budget reflects increase in total student activity funds which will allow SGA and the campus RSO's to allocate larger budgets to programming, events, and general supplies.
